CORPORATE TEAM COMMITMENT - \$3,500 (8 SPOTS)

The Corporate Climb team fee of \$2,260 is a tax-deductible charitable contribution. The \$1,240 participant entry fees can be paid by your organization or by individuals at the time of their registration (\$155 per person). This includes a \$55 registration fee and a \$100 fundraising minimum (non-refundable). Of the \$155, \$100 fundraising minimum is a tax-deductible charitable contribution; the \$55 registration fee is not tax-deductible. Multiple teams of 8 participants are available, at the same commitment of \$3,500 per team.

The Hustle Corporate Climb Team Commitment Form deadline is **February 26, 2021**. The Commitment Form must be received *before* custom registration information can be provided for individuals to register. The Corporate Climb Team Entry Fee of \$2,260 is due by **March 26, 2021**. Please note, reserved spaces are held for a limited time. Unfilled corporate team spots will be forfeited without refund.



Hustle Chicago Payment Options

Option A

Company pays team fee of \$2,260 and \$1,240 participant entry fees.
8 spots total: \$3,500

Option B

Company pays \$2,260 team fee.
Individuals pay \$155 entry fee (per participant).
8 spots total: \$3,500

What happens if the in-person event is cancelled?

If we are unable to host the event on April 18 due to COVID-19 restrictions, we will work with Soldier Field to reschedule the in-person climb (if possible). If we must move to a virtual-only event, you can choose to:

- 1) Participate in our interactive virtual event and let RHA retain your \$2260 team fee as a donation.
- 2) Request your \$2260 donation roll over to the 2022 in-person event.

If your company decides to continue with our virtual event but individual team members no longer wish to participate:

- 1) If your company paid for all entry fees, you may sub team members to replace people no longer participating. Unfortunately, we cannot offer partial refunds.
- 2) If the climber pays, you can have a refund of \$55 registration fee only if no substitution is available.

Please note that individual fundraising minimums (\$100) charged at the time of registration are non-refundable.
